About the Conference:

The United Nations has proclaimed <u>May 22 the International Day for Biological</u> <u>Diversity (IDB)</u> to increase understanding and awareness of biodiversity issues. When first created by the Second Committee of the UN General Assembly in late 1993, 29 December (the date of entry into force of the Convention of Biological Diversity), was designated The International Day for Biological Diversity.

In 2018, the Convention on Biological Diversity will celebrate <u>25 years</u> since its entry into force. On June 5th 1992, the Convention on Biological Diversity (CBD) was adopted and opened for signature. This is a land mark moment in the history of the CBD that could be used to enhance the profile of biodiversity

The 25th anniversary is an opportunity to celebrate the achievements of the Convention, to communicate to the world the importance of biodiversity, and also to urge strengthened efforts to achieve the **Strategic Plan for Biodiversity 2011-2020** and related commitments including the Sustainable Development Goals.

Celebration of the IDB under this theme therefore provides an opportunity to raise awareness and action towards the important contribution towards **Conservation and Importance of Biodiversity**.

State Biodiversity Board, Lucknow is celebrating International Day for Biological Diversity (IBD) **22nd May, 2018** on the theme "Celebrating **25 Years of Action for Biodiversity".** The aim of the conference is to create awareness about Biodiversity Conservation and educate the people about importance of Biodiversity as the loss of biodiversity has become a serious issue.

- Theme: one among the above

The selected and relevant articles will be published in the **E-Souvenir and will be uploaded in the website.** The softcopy of the published articles will be provided to the authors. The participants are requested to send their valuable papers/articles for the benefit of mankind.
